

### GUARANTEES / WARRANTIES

Parts & Labor. 90 Days  
Service Call. 30 Days

Our Warranty covers only the parts used for this repair. Other parts & faults / problems of this appliance are not covered under this warranty.

If Appliance breaks down within 30 days and cause is the "parts used for this repair are malfunctioning". You are eligible for free replacement of same parts at no cost to you. After 30 days you have to pay Service Call charges only and parts & Labor are still covered for 60 more days.

If you are having same or different problem in your appliance because of some other faulty parts of appliance, it is not covered under this Warranty. You have to pay for parts & labor (but no service call during first 30 days of repair.) Afterwards it would be considered as new repair call.

We guarantee only the parts used for this repair will perform satisfactory under the conditions of normal usage for 90 days with exception: all commercial, used glass parts and cosmetic are guaranteed for 30 days.
